



Earnings Flash Note Al Faleh Educational Holding 1Q 2026

Al Faleh Educational Holding Co. (FALH)

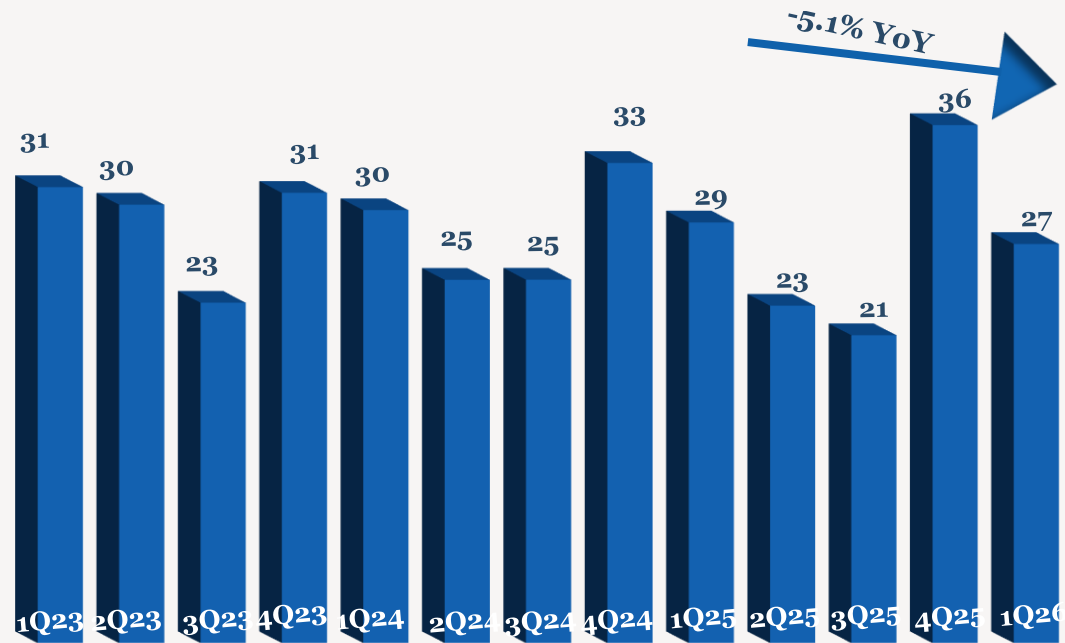
- > Net profit increased by 29.4% YoY to QR3mn (-60.4% QoQ) in 1Q2026 primarily due to lower cost of operations.
- > Revenue fell 5.1% YoY to QR27mn (-22.9% QoQ) in 1Q2026.
- > Gross profit grew 9.9% YoY to QR17mn (+18.0% QoQ) while the corresponding margin came at 61.4% (vs 53.0% in 1Q2025) in 1Q2026.
- > Operating profit was up 42.5% YoY (-57.7% QoQ) to QR4mn in 1Q2026 while the corresponding margin came at 14.8% (vs 9.9% in 1Q2025) in 1Q2026.
- > For 1Q2026, EPS came at QR0.013 vs. QR0.010 in 1Q2025.
- > As of 29th December 2025, the stock has increased 1.1% YTD, Underperforming the QSE Index, which was up by 2.1% YTD.
- > The stock is currently trading at a TTM P/E multiple of 11.5x.

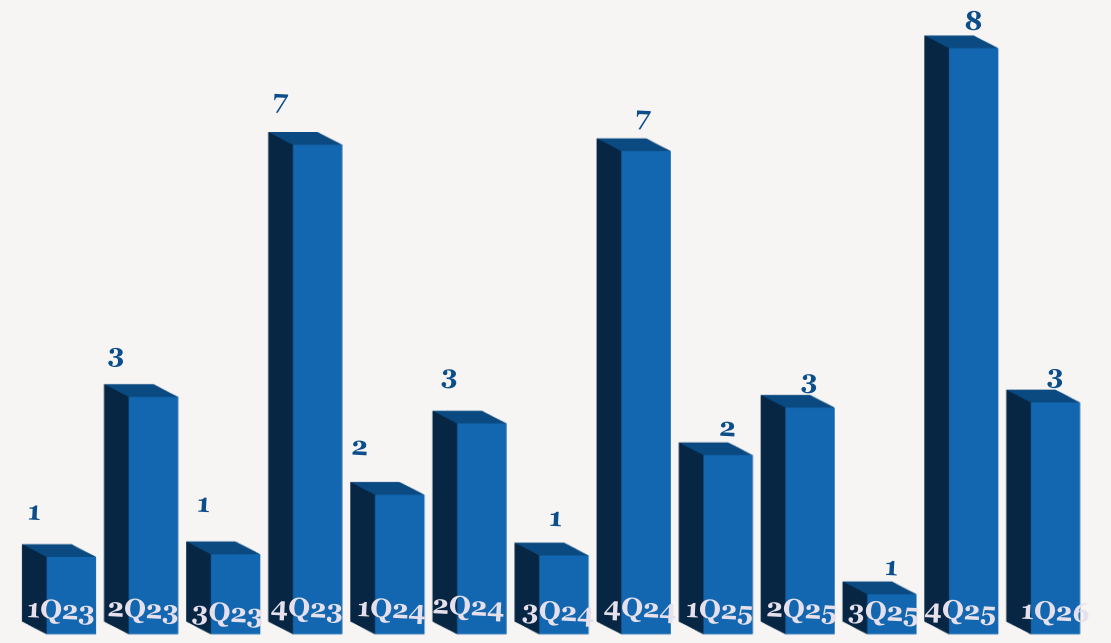

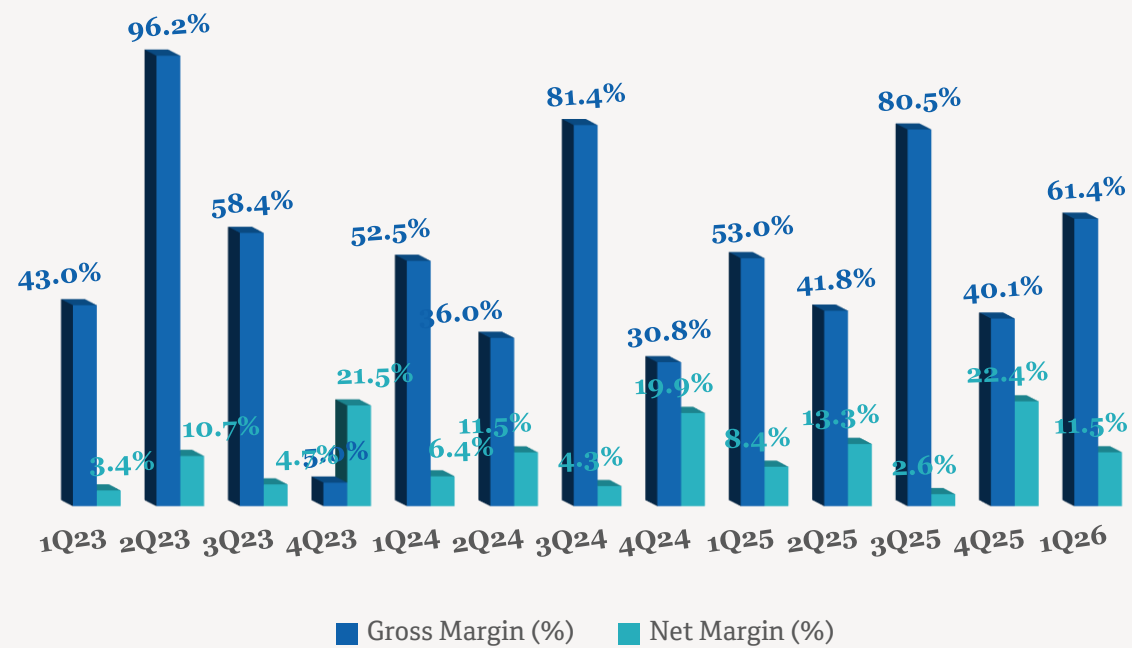
Quarterly Sales Trend (QRmn)



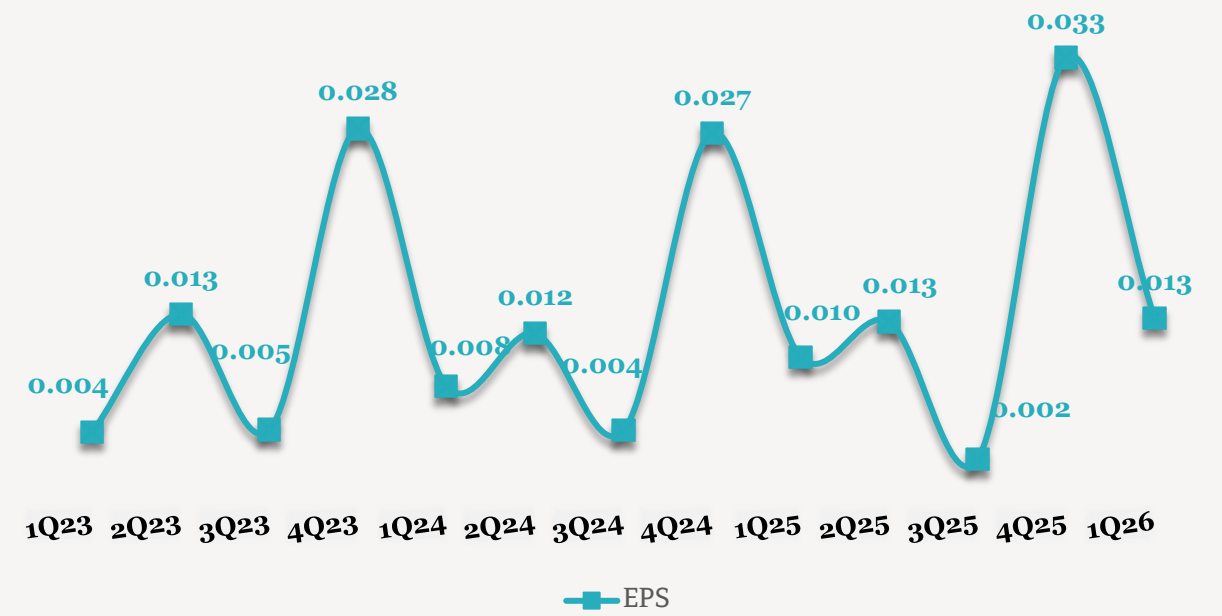
Quarterly Earnings Trend (QRmn)
